

**Lightlife® Family Movie Night Sweepstakes  
OFFICIAL RULES**

**NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN.**

**A PURCHASE OR PAYMENT WILL NOT IMPROVE YOUR CHANCES OF WINNING.**

**1. SPONSOR:** The Lightlife® Family Movie Night Sweepstakes (referred to hereafter as “Sweepstakes”) is sponsored by Greenleaf Foods, SPC d/b/a Lightlife Foods, located at 180 W Park Ave Suite 300 Elmhurst, IL 60126 (“Sponsor”).

**2. SWEEPSTAKES ENTRY PERIOD:** Sweepstakes begins on May 16, 2022, at 12:00 a.m. Central Time (“CT”) and ends on August 15, 2022, at 11:59 p.m. CT (“Sweepstakes Entry Period”). Sponsor’s or its agency’s computer system will be the official timekeeper of the Sweepstakes. Internet access charges imposed by your online service provider may apply. If you are using a mobile device to enter the Sweepstakes, standard data rates may apply from your wireless carrier.

**3. ELIGIBILITY:** Sweepstakes is open to legal residents of the 50 United States and the District of Columbia who are at least 18 years of age or the age of majority in their state of legal residence, whichever is older, at time of entry. Employees and their immediate family members of Sponsor, Walt Disney Studios Motion Pictures (“Disney”), Fandango Media, LLC, Poppin’ Jay, Inc. d/b/a Blue Chip, Ventura Associates International LLC (“Administrator”), their parent companies, affiliates, subsidiaries, advertising agencies, promotion agencies involved in this Sweepstakes (collectively, the “Sweepstakes Entities”) are not eligible to participate or win. Void where prohibited by law.

The term “immediate family members” means parents, step-parents, children, step-children, siblings, step-siblings, spouses or grandparents, regardless of where they live.

By participating, you agree to abide by and be bound by these Official Rules, and the decisions of Sponsor and its agents are final and binding in all respects.

**4. HOW TO ENTER:** During the Sweepstakes Entry Period, there are two (2) ways to enter the Sweepstakes.

Online method: upload purchase receipt:

If you make any Lightlife® purchase during the Sweepstakes Entry Period, circle the Lightlife® food on your receipt, scan or take a picture of your receipt, then upload the image of your receipt at [www.LightlifeMovieNight.com](http://www.LightlifeMovieNight.com) (“Website”), and follow the onscreen instructions to submit your information. You will earn one (1) entry in the Sweepstakes regardless of how many Lightlife® food items purchased on that receipt. Visit <https://lightlife.com/where-to-buy/> to find a store near you (or online retailers) to purchase your Lightlife® food. Sponsor is not responsible for any Lightlife® product availability at any store or retailer. Uploading the same or duplicate receipt using a different identity is prohibited. Limit one (1) entry (i.e., receipt upload) per person per day. See overall limit below.

Mail-in method: no purchase required:

To enter without making a purchase, handwrite your full name, complete mailing address, valid email address and telephone number on a piece of paper, insert that paper in a #10 business size envelope and mail the envelope with sufficient postage via USPS First Class mail to: Lightlife® Family Movie Night Sweepstakes Entry, P.O. Box 1307, Palatine, IL 60078-1307. **Each mail-in entry must be handwritten on a piece of paper and mail one (1) entry per envelope.** Mechanically reproduced/photocopied or postage due mail-in entries will not be accepted. If you mail more than one (1) entry inside an envelope, only the first entry will be considered in a random drawing. Limit of one (1) mail-in entry per person per day. The postmark date will be the entry date. If your entry is mailed on a Sunday or Federal Holiday, then your mail-in entry must be postmarked the next business day (the number of mail-in entries limit received on that business day will be accepted accordingly). See overall limit below. All mail-in entries must be postmarked by August 15, 2022, and received by August 22, 2022.

**Regardless of entry method, there is a limit of one (1) entry per person per day (for a total of up to ninety-two (92) entries per person during the Sweepstakes Entry Period).** For the purpose of these Official Rules, “per day” begins at 12:00 a.m. CT and ends at 11:59 p.m. CT on the same calendar day. Entries that exceed this limit per person will be discarded. At Sponsor’s sole discretion, Sponsor may

disqualify all entries associated with the entrant if discovered he/she/they uploaded the same receipt or mail multiple entries using a different identity. Incomplete entries will be disqualified. Sponsor is not responsible for entries or receipts that are late, garbled, damaged, illegible, deleted or misdelivered. Entries using bots or other forms of automatic entry will be disqualified. Multiple entrants are not permitted to share the same email address. Sponsor may prohibit an entrant from participating in the Sweepstakes or winning a prize if, in its sole discretion, it determines that said entrant is attempting to undermine the legitimate operation of the Sweepstakes by cheating, deceiving or using other unfair playing practices or otherwise violating these Official Rules. Sponsor reserves the right to cancel, modify, or suspend the Sweepstakes at any time without notice, if fraud, technical failures, any unanticipated occurrence that is not fully addressed in these Official Rules or any other errors or other causes corrupt the administration, security, or integrity of the Sweepstakes. In the event of cancellation, Sponsor reserves the right to select the winners by random drawing from among all eligible, non-suspect entries received up to the time of such cancellation, and in a manner determined by Sponsor to be fair, appropriate, and consistent with these Official Rules. Notice of any such cancellation, modification or suspension will be posted on the Website. If there is a dispute as to the identity of an entrant, the prize will be awarded to the authorized account holder of the email address associated with the winning entry. The "Authorized Account Holder" is defined as the natural person to whom the email address is assigned by an online service provider or other organization that is responsible for assigning email addresses for the domain associated with the submitted email address. If a dispute cannot be resolved to Sponsor's satisfaction, the affected entry will be deemed ineligible. All received entries become the property of Sponsor and will not be acknowledged or returned.

Should entrants choose to share any post on social media relating to this Sweepstakes, such sharing does not affect the odds of winning a prize in this Sweepstakes or result in any additional entry in the Sweepstakes.

**5. PRIZES AND THEIR APPROXIMATE RETAIL VALUES ("ARV"):** A total of eighty-two (82) prizes will be awarded.

**One (1) Grand Prize:** A private screening of a movie at a movie theater near winner's hometown. Winner can choose one (1) out of three (3) movie choices and invite up to 99 guests to watch the chosen movie. Grand Prize ARV: up to \$3,000. A prize fulfillment vendor will coordinate with the winner to schedule the private screening. Private screening includes snacks and soft drinks offered at the theater. If winner chooses to invite less than 99 guests, the remaining portion of prize will be forfeited and shall constitute full satisfaction of Sponsor's prize obligation to winner and no additional compensation will be awarded. Winner is responsible to make sure that any guest who is a minor must be accompanied by guest's parent. Prize does not include any transportation, parking or accommodation. Sponsor shall have no responsibility or liability for movie cancellation, delay, or any other change by any person providing any element of the prize and are not responsible or liable for any expenses incurred as a consequence thereof. Winner and guests agree to comply with all applicable rules and regulations in connection with prize. Prize may not be sold, transferred or otherwise exploited for commercial use. Guests may be required to sign a liability/publicity release prior to the private movie screening. Please note that any public location where people are present provides an inherent risk of exposure to contagious and communicable illness, and Sponsor is not responsible for any person who may be exposed to such risk during the screening. Furthermore, Sponsor is not responsible for any food allergy and/or food restrictions of any person benefiting from prize awarded. If for any reason winner's hometown is not suitable for the private screening, or if winner does not choose a movie from the movie selections on date/time provided by the prize fulfillment vendor, the prize may be forfeited at Sponsor's sole discretion or winner may elect to receive \$3,000 cash in lieu of the private screening (cash will be awarded in the form of a corporate check).

**Twenty (20) First Prizes:** Each winner will receive a Disney® premium prize pack. First Prize ARV: up to \$100 each prize pack. Premium prize pack may include items such as a hat, t-shirt, jacket, water bottle or backpack. Selection of premium items is at Sponsor's sole discretion.

**Twenty-nine (29) Second Prizes:** Each winner will receive a Fandango Promotional Code ("Fandango Promo Code"). Second Prize ARV: \$60 each (4 movie tickets, up to \$15 each). Each Fandango Promo Code is good towards the purchase of four movie tickets (up to \$15 total ticket and convenience fee value per ticket) to see any movie at Fandango partner theaters in the US. Fandango Promo Code is void if not redeemed by 9/30/22. Only valid for purchase of movie tickets made at Fandango.com or via the Fandango app and cannot be redeemed directly at any theater box office. If lost or stolen, cannot be replaced. No cash value, except as required by law. Void where prohibited. Not valid with any other offer. One-time use

only. Not for resale; void if sold or exchanged. If cost of movie tickets with Fandango's convenience fee included is more than maximum value of the Fandango Promo Code, then user must pay the difference. Any price difference between movie tickets purchased and maximum value of the Fandango Promo Code will not be refunded. The redemption of the Fandango Promo Code is subject to Fandango's Terms and Policies at [www.fandango.com/terms-and-policies](http://www.fandango.com/terms-and-policies).

**Thirty-two (32) Third Prizes:** Each winner will receive \$50 Disney® e-Gift Card. Third Prize ARV: \$50 each. Usage of Disney® e-Gift Card is subject to Disney® gift card terms and conditions.

No substitution or cash redemption permitted. Prizes are non-transferable and non-refundable. Sponsor reserves the right, in its sole discretion, to substitute a prize with a prize of comparable value if the stated prize becomes unavailable for any reason. Prize is awarded as is or winner forfeits all rights to prize. All winners acknowledge that the Sweepstakes Entities and their agents do not make, nor are in any manner responsible for, any warranty or representations, expressed or implied, in fact or in law, relative to the quality, conditions, fitness or merchantability of any aspect of a prize. **6. WINNER SELECTION AND NOTIFICATION:** Random drawings will be conducted on or about August 29, 2022 under the supervision of the Administrator whose decisions are final and binding. Potential winners will be selected from all eligible entries received. In the event an insufficient number of eligible entries are received, the higher value prizes will be awarded first, and any unawarded lower value prize(s) will be forfeited. All winners will be notified via email at the email address provided on the entry within three (3) business days after the random drawings are conducted. E-Gift Card and eTicket prize winners will receive their prizes via email. Potential Grand Prize winner will be required to complete and return a signed and notarized Affidavit of Eligibility/Liability and a Publicity Release ("Affidavit") within seven (7) days as directed on the email notification. If the Affidavit is not returned completed within the date specified or if an Affidavit or prize notification is returned as undeliverable, or if a potential prize winner is otherwise found to be ineligible, or if a potential prize winner cannot accept/receive the prize for any reason, or if a potential winner fails to comply with these Official Rules, that potential winner will be disqualified and the corresponding prize may be awarded to an alternate winner by random drawing from remaining eligible, non-winning entries. Attempts will be made to contact and/or verify up to at least five alternate Grand Prize winner. After five (5) attempts to verify a winner for the unfulfilled prize fail, the prize may not be awarded at Sponsor's sole discretion. Grand Prize winner will be required to furnish his/her Social Security Number to the Administrator on the Affidavit and an IRS Form 1099-Misc will be filed in the name of the winner for the prize value awarded.

Sponsor is not responsible for any change of mailing address and/or contact information of any entrants during the course of the Sweepstakes or period when prizes are being fulfilled. Sponsor is not responsible for any returned/undeliverable prizes, delays in prize delivery caused by the delivery carrier, or unclaimed prizes. Returned, undeliverable, or unclaimed prizes will be forfeited. If due to a printing, production or other error, more prizes are notified or claimed than the stated number of prizes intended to be awarded for any prize level, the intended prizes will be awarded in a random drawing from among all verified and validated prize claims received for that prize level. In no event will more than the stated number of prizes be awarded.

**7. LIMITS ON LIABILITY:** By entering, you (i) agree to be bound by these Official Rules, including all eligibility requirements; (ii) agree to be bound by the decisions of Sponsor and the Administrator, which are final and binding in all matters relating to the Sweepstakes; and (iii) release, hold harmless, and indemnify Sweepstakes Entities, from, and hereby waive any claims to, all claims, losses, injury, damages, and liability of any kind to person(s), including death, or property damage arising directly or indirectly or relating to your acceptance, possession, use and/or misuse of a prize, and participation in the Sweepstakes, including privacy or right of publicity claims or claims related to merchandise delivery.

Entrants further understand and agree that all rights under Section 1542 of the Civil Code of California ("Section 1542") and any similar law of any state or territory of the United States that may be applicable with respect to the foregoing release are hereby expressly and forever waived. Entrants acknowledge that Section 1542 provides that: "A general release does not extend to claims which the creditor or releasing party does not know or suspect to exist in his or her favor at the time of executing the release, which, if known by him or her would have materially affected his or her settlement with the debtor or released party." Entrant acknowledges that the releases herein are intended to apply to all claims not known or suspected to exist with the intent of waiving the effect of such laws to preserve future unknown claims.

The Sweepstakes Entities do not warrant that access to the Sweepstakes will be uninterrupted and are not responsible for: (a) entries from persons residing, or physically located, outside the eligible area mentioned in section 3 above; (b) entries that are altered, delayed, deleted, destroyed, forged, fraudulent, improperly accessed, inaccurate, incomplete, interrupted, irregular in any way, misrouted, multiple, non-delivered, stolen, tampered with, unauthorized, unintelligible or otherwise not in compliance with these Official Rules; (c) lost, interrupted or unavailable networks, servers, satellites, or other connection, availability, or accessibility problems arising in connection with or over the course of the Sweepstakes; (d) failure of personal computers and/or software and hardware configurations, any technical malfunctions, failures, or difficulties, clerical, typographical or other errors in connection with the administration of the Sweepstakes, the processing of entries, or the offering or announcement of the prizes or in any prize notification documents; (e) any other errors of any kind relating to or in connection with the Sweepstakes, whether human, mechanical, clerical, electronic, or technical in nature; (f) the incorrect or inaccurate capture of information, or the failure to capture any information in connection with the Sweepstakes, (g) damage to entrant's system occasioned by participation in this Sweepstakes or downloading any information necessary to participate in this Sweepstakes; even if caused by the negligence of any of the Sweepstakes Entities, or (h) inability to implement the Sweepstakes or award the prizes as contemplated herein due to any "force majeure" event beyond its control, including delays or interruptions caused by acts of God, acts of war, natural disasters, pandemic, weather, utility outages, acts of terrorism or any federal, state, or local government law, order, or regulation, order of any court or regulator.

DISPUTES:** If any part of these Official Rules is deemed to be invalid or otherwise unenforceable or illegal, the balance of these Official Rules will remain in effect and will be construed in accordance with its terms as if the invalid or illegal provision were not contained herein. Except where prohibited, entrants agree that: (a) any and all disputes, claims, and causes of action arising out of or connected with this Sweepstakes or any prize awarded must be resolved individually, without resort to any form of class action, and exclusively by a federal or state court located in New York, NY; (b) the Sweepstakes will be governed and enforced pursuant to the laws of the State of New York and the federal laws of the United States of America, without regard to the conflicts of laws provisions thereof; (c) any and all claims, judgments and awards will be limited to actual out-of-pocket costs incurred, including costs associated with entering this Sweepstakes, but in no event attorneys' fees; and (d) UNDER NO CIRCUMSTANCES WILL ENTRANT BE PERMITTED TO OBTAIN AWARDS FOR, AND ENTRANT HEREBY WAIVES ALL RIGHTS TO CLAIM INDIRECT, PUNITIVE, INCIDENTAL, AND CONSEQUENTIAL DAMAGES AND ANY OTHER DAMAGES, OTHER THAN FOR ACTUAL OUT-OF-POCKET EXPENSES, AND ANY AND ALL RIGHTS TO HAVE DAMAGES MULTIPLIED OR OTHERWISE INCREASED. Notwithstanding the foregoing, any and all disputes, claims and causes of action arising out of or connected with the intellectual property of Disney, shall be resolved individually, without resort to any form of class action, shall be governed and construed in accordance with the laws of the state of California and in the event of any dispute, all entrants irrevocably consent to the jurisdiction of the state and federal courts located in Los Angeles, California to resolve such disputes.
